

Sweepstakes Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. **Eligibility:** This Sweepstakes is open only to those who enter for a chance to win by requesting more information from PTO Today and Get Movin' FUNdraising at www.ptotoday.com/get-movin-fundraising and who are 18 as of the date of entry.

The Sweepstakes is only open to legal residents of the United States and is void where prohibited by law. Employees of School Family Media (SFM), Get Movin' FUNdraising, and their affiliates, subsidiaries, advertising and promotion agencies, and suppliers (collectively the "Employees"), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the Sweepstakes. 3. **Sweepstakes Period:** Entries will be accepted starting Sept. 4, 2019, at 12:01 a.m. (Eastern Daylight Time) and ending Sept. 30, 2019, at 11:59 p.m. (Eastern Daylight Time). All entries must be received by Sept. 30, 2019, at 11:59 p.m. (Eastern Daylight Time).
4. **How To Enter:** Submit an entry by requesting more information from PTO Today and Get Movin' FUNdraising via the registration process on www.ptotoday.com/get-movin-fundraising. By requesting more information, You are granting SFM and Get Movin' FUNdraising right to email You at the email address You provided upon entry. The entry must fulfill all Sweepstakes requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of SFM.
5. **Limited to one entry per person.** You must provide the information requested. You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules. If You use fraudulent methods or otherwise attempt to circumvent the rules, Your submission may be removed from eligibility at the sole discretion of SFM.
