

## PTO Today #ptolife Yankee Candle Set Giveaway -- Sweepstakes Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. **Eligibility:** This Sweepstakes is open to those associated with a school parent group who enter for a chance to win by requesting more information from PTO Today and Yankee Candle Fundraising at [www.ptotoday.com/yankeecandle](http://www.ptotoday.com/yankeecandle) and who are 18 as of the date of entry.

The Sweepstakes is only open to legal residents of the United States and is void where prohibited by law. Employees of School Family Media LLC (SFM), Yankee Candle Fundraising, and their affiliates, subsidiaries, advertising and promotion agencies, and suppliers (collectively the "Employees"), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the Sweepstakes. By requesting more information, You are granting SFM and Yankee Candle Fundraising the right to email You at the email address You provided upon entry. The entry must fulfill all Sweepstakes requirements, as specified, to be eligible to win a prize.
